On 24 October 2016, the Company granted 40,000,000 share options to certain directors, employees and consultant of the Company under Share Option Scheme adopted on 26 August 2014, with the validity period being 3 years from 24 October 2016 to 23 October 2019 (both days inclusive). Details of the grant of Share Options are set out in the announcement of the Company dated 24 October 2016.

On 5 March 2019, the Company granted 51,100,000 share options to certain directors and employees under Share Option Scheme adopted on 26 August 2014, with the validity period being 2 years from respective vesting Dates. The 30,120,000 Options will vest immediately on the Date of Grant (from 5 March 2019 to 4 March

2021) (both days inclusive); and remaining 20,980,000 Options will vest 1 year after the Date of Grant (from

5 March 2020 to 4 March 2022) (both dates inclusive). Details of the grant of Share Options are set out in the

announcement of the Company dated 5 March 2019.
