PLEDGE OF SHARES BY CONTROLLING SHAREHOLDER

This announcement is made by New Concepts Holdings Limited (the “**Company**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

The Company has been notified by Prosper Power Group Limited (“**Prosper Power**”), the Company’s controlling shareholder (as defined in the Listing Rules) that on 3 November 2015, Prosper Power entered into a loan agreement (the “**Loan Agreement**”) with an independent third party which is an entity independent of the Company and its connected persons (as defined in the Listing Rules) (the “**Lender**”) in relation to the provision of a loan to the Company in the principal amount of HK\$360,000,000 (the “**Loan**”) and pursuant to which Prosper Power has pledged 184,000,000 shares of the Company (the “**Charged Shares**”) as security for the Loan in favour of the Lender, which, to the best of the knowledge, information and belief of the Directors after having made all reasonable enquires, is a finance company and also has a money lender licence issued under the Money Lenders Ordinance, Cap. 163 of the Laws of Hong Kong. The Charged Shares represent approximately 46% of the shares capital of the Company as at the date of this announcement.

The above pledge of shares does not fall within the scope of Rule 13.17 of the Listing Rules.
