PARTIAL CONVERSION OF CONVERTIBLE BOND

Reference is made to the announcement of New Concepts Holdings Limited (the “**Company**”) dated 15 April 2021 (the “**Announcement**”) in relation to the issue of convertible bond (the “**Convertible Bond**”) in the aggregate principal amount of approximately HK\$16,826,000. Capitalised terms used herein shall have the same meanings as those defined in the Announcement unless stated otherwise.

The Board announces that the Company received conversion notices from Subscriber A and Subscriber B on 14 July 2021 and 13 July 2021 exercising their respective rights to convert the second tranche of the Convertible Bond issued to them in the principal amount of HK\$3,510,000 and approximately HK\$1,538,000, respectively, at the Conversion Price of HK\$0.26 per Conversion Share (the “**Conversion**”).

Following the Conversion, 13,500,000 and 5,912,000 Conversion Shares will be allotted and issued by the Company to Subscriber A and Subscriber B, respectively under the general mandate of the Company granted by the Shareholders to the Directors at the annual general meeting of the Company held on 25 September 2020. The Conversion Shares will rank *pari passu* with all the existing Shares in issue as at the date of allotment and among themselves in all respects.

Immediately after the allotment and issue of the Conversion Shares, the number of issued shares of the Company will increase by 19,412,000 Shares to 928,358,134 Shares. Taking into account the issue of 400,000 new Shares arising from exercise of share options on 21 July 2021 (“**Exercise of Options**”), the total number of issued Shares of the Company on the Conversion date (i.e. 21 July 2021) is 928,758,134 Shares. The 19,412,000 Conversion Shares represent approximately (i) 2.14% of the existing issued share capital of the Company immediately prior to the Conversion; and (ii) approximately 2.09% of the issued share capital of the Company as enlarged by the allotment and issue of the Conversion Shares.
