On 19 April 2021, the Company granted 46,492,000 share options to certain Directors, employees, and a Consultant under the Share Option Scheme on 26 August 2014 (the "Share Option Scheme"). 16,892,000 Options were vested immediately on the Date of Grant (from 19 April 2021 to 18 April 2023); 14,800,000 Options will be vested on the first anniversary from the Date of Grant (from 19 April 2022 to 18 April 2024), and the remaining 14,800,000 Options will be vested on the second anniversary from the Date of Grant (from 19 April 2023 to 18 April 2024). Details of the grant of Share Options are set out in the announcement of the Company dated 19 April 2021.
